### "Our Mission Is Your Safety"

The 2022 season for Blue Mountain Interagency Dispatch Center (BMIDC) arrived in the form of abundant out-of-GACC support in the spring shoulder season. Our footprint steadily supported Eastern Area RX operations, then shifted to suppression assistance in the Southwest in early April through May.

While the BMIDC footprint experienced a short burst of activity in late July into early August, we remained atypically slow for August, with persistent hot and dry conditions. A slow August morphed into an uncommonly late start with the ignitions of the Double Creek, Sturgill, and Nebo fires at the end of the month. With a strong interagency effort, these fires were managed by two different T1 Teams and partners throughout September.

The NEO T3 Team both ramped up and ramped down with the Double Creek incident beginning Aug. 31st, and handing it back to the Wallowa Fire Zone Oct. 15.

While focused on support to the field and care for our employees, BMIDC ran expanded with both in person and virtual positions. We've continued to see success with this strategy and retention of quality expanded staff.

Fire season officially ended October 25th with abnormal warm weather through the end of the month. Activity dropped off significantly after this, lending to a quiet fall shoulder season.

Special thanks to the BMIDC Ops group, Board of Directors, Line Officers and the Radio Group for your unwavering support. As always, we continue to strive for exemplary service to all



## La Grande Fire Interagency Support Cache

The 2022 season at the La Grande Fire Cache got its kick start in May. Annual kit updates and routine preparation for the 2022 season were the primary focus of the crew.

This year we welcomed two new 1039 employees to the cache, John Schiller and Robert (Bobby) Askins. The La Grande Fire Cache employed a total of 13 Administratively Determined (AD) employees, to increase our workforce. AD salaries paid in support of the La Grande Fire Cache totaled approximately \$106,851, helping boost the local economy. With the busy season in the Pacific Northwest this year we hosted 6 detailersfrom the Rocky Mountain (Lakewood, CO) and Silver City Fire (Hurley, NM) Caches. The La Grande Fire Cache was also able to provide support to other National Caches by sending a total of 6 detailers out on fire assignment to the following National Caches, located in Fairbanks, AK, Silver City, NM, Wenatchee, WA, Redmond, OR and Ontario, CA.

During the 2022 season the La Grande Cache provided \$21,628,716 in support to both Regional and National Caches by shipping and delivering supplies items in support of ongoing incidents. The Cache also provided legal support to 1 Type 1.1



incidents. The Cache also provided local support to 1-Type I, 1-Type II, and 4-Type III incidents on the Wallowa-Whitman NF, Umatilla NF, Malheur NF, as well as to the Oregon Department of Forestry. In addition, resource requests for small initial attack incidents kept the crew busy. Cache personnel also assisted with the Region 6 Rappel Academy as well local unit needs for the Oregon Department of Forestry, Washington DNR, local BIA and BLM units.

Our overall inventory value for 2022 totaled \$8,144,783. The dollar amount issued directly out to incident support for the 2022 fire season was \$6,253,993. Total dollar amount returned from incidents was \$5,822,918. Total miles driven this year in support of incidents, accident free, was 26,877.



#### Air Attack N78NA

La Grande Air Attack AA616 (8NA) began the season stationed in R3 from April 08, 2022 to May 30, 2022. From 05/31/2022 to 07/03/2022 AA616 was stationed in Region 8. On July 4th the platform moved back to R6. 8NA finished up the fire season September 30, 2022. 8NA flew 416 hours, and had 3 AA trainees for 28 days of training.

The La Grande Air Tanker Base provided retardant services and support personnel for safe, fast and efficient loading. ODF funded the SEATs and provided a SEMG. This is a very successful partnership for all agencies within the BMIDC footprint. The tanker base opened for fire support on June 1, 2022. The tanker base hosts two Oregon Department of Forestry (ODF) contract SEATs. T822 and T869 were hosted this year on a 75 day contract. On June 28, 2022 the first loads of the season left La Grande in support of suppression activities on Willow Creek fire in Washington. The busiest stretch for the tanker base was August 22 to September 2 with 359,909 gallons delivered to 10 fires. The single busiest day was August 31 with 90,410 gallons delivered to the Crocket's Knob and Double Creek Fire. Last load of the season was sent the Cedar Creek Fire in western OR on October 8. 324 missions were flown from the La Grande Tanker Base. 14 individual Large Airtankers and 7 individual SEAT's made us of the tanker base. The tanker base pumped 691,605 total gallons of retardant, costing incidents \$2,054,079 in 2022. The tanker base is a force account base so there are no retardant contract costs. This was La Grande Air Tanker Base's 31st season with out an accident or incident with Large Air Tankers.

## **Aviation - Rotor Wing**

### Type 1 Helicopters

#### **T1 Limited Helicopters**

This summer was different to previous summers in that there was not a Type 1 Helicopter hosted by the Wallowa Whitman N.F. The Grande Ronde Rappellers managed 3 different Type 1 Helicopters. N261CG was managed for 45 days, with 101.7 hours of flight time, delivering 219,000 gallons of water on fires in NE Oregon. Helitanker 718 was managed for 72 days with 141.1 flight hours, delivering 496,850 gallons of water in the Southwest Region, mostly on the Calf Canyon Fire. Helitanker 722 was managed for 72 days, with 132.9 flight hours, mostly in central OR and on the Cedar Creek Fire.

# T2 Limited Helicopter N703NP

3NP's season ran from July 12 - September 24, with a total of 47.4 hours flown in the 2022 season. This flight time occurred on 16 incidents. Totals for the season were 16.3 hours on ODF fires and 31.1 hours on federal incidents. 3NP delivered 312 buckets for the 2022 fire season. 137 buckets were delivered to the Nebo, Sturgill, and Goat Mountain 2 fires. These fires account for 14.5 hours of the 2022 season's flight time.









N404HA (Bell 205 A1++) was on a 120-day contract in 2022, extending for 23 days, 4HA and crew flew181.2 total flight hours, of those, 79.9 flight hours were on the home forest of WWF, 4HA and crew supported 28 initial attack fires with either rappellers or helitack. 4HA also provided extended attack fire support on large fires in Alaska and Oregon, including the Double Creek Fire on the home unit.

N223HT (Bell 205 A1++) was on a 120-day contract in 2022, extending for 12 days. 3HT flew 222.6 hours, almost evenly divided between on and off home unit (104.1 hours on home unit, 111.9 hours off home unit) supporting initial and extended attack fires in Arizona, New Mexico, Idaho, Washington, and Oregon. 3HT provided initial attack on 32 fires with either rappellers or helitack.






- 2022 was below for number of stat fires and above average on acreage burnt for the season.




