WEATHER HIGHLIGHT

Clear skies were seen across the area yesterday. Temperatures were in the 60s along the coast, 80s on the west side of the Cascades and 90s on the east side except for the Columbia Basin which reached into the 100s. Relative humidities were in the 20s to 40s on the west side and in the teens and 20s on the east. Winds were light with some gust in the 0s. No precipitation was received, and lightning was light across the geographic area. Initial attack activity was moderate. Multiple fires grew to 100 acres.
