WEATHER HIGHLIGHT

Temperatures continue to moderate west of the Cascades with temperatures from the mid -60s to low 80s. East of the Cascades high temperatures were in the 80s to 90s. Relative humidities were mid-teens to mid-20s in eastern portion of the Geographic Area and 30-40s west. Strong gusty winds surfaced in eastern Oregon with speeds in the mid-20s. Outflow gusts were much stronger. Scattered precipitation was received with storms. Heavy lightning occurred in eastern Oregon. Initial attack was moderate. Cedar Creek and Hole in the Ground fires grew to 2,000 acres.
