East of the Cascades high temperatures were slightly lower, 80s to 90s. Relative humidities were in the teens in eastern portion of the Geographic Area and 30s-60s west and along the coastal range. Winds surfaced in eastern Oregon with speeds in mid-20s. Gusts returned to a more diurnal pattern; Harney Basin had gusts in mid 40s. Light precipitation occurred in northwest Washington.
