WEATHER HIGHLIGHT

Temperatures were in the 70-80s in northwest Oregon and western Washington, elsewhere they rose into the 80-90s. Relative humidity east of the Cascades dropped below 20 percent with single digits in southeast Oregon while the west side stayed above 30 percent. Winds were breezy across the geographic area with gusts between 35-45 mph in north central Washington and southeast Oregon. Moderate lightning amounts east of the Cascades. Scattered precipitation in northern Oregon and southern Washington. Initial attack was heavy with three starts in excess of 350 acres on the east side of Oregon. Existing large fires showed active fire behavior.
