WEATHER HIGHLIGHT

Cooler temperatures and higher humidity for most areas today. Residual thunderstorms from last night's activity should end around mid-day. High pressure returns overhead Wednesday with significant warming, drying, and low-level instability. A thermal trough sets up over western PSAs bringing strong ventilation potential to fires in the Cascades and moderate potential elsewhere. Decreasing humidity recovery and easterly flow will prolong fuel drying periods for western PSAs. Mainly dry thunderstorms are possible across southern Oregon Friday but are much more likely Saturday. These storms could produce moderate lightning counts along with strong outflow wind.
