WEATHER HIGHLIGHT

The Geographic Area is between weather systems today. Gusty west winds push through the lower Cascade gaps and across the Columbia Basin. Marine air will bring higher humidity to the western Basin but with little effect further east. Dry and breezy southwest wind will cross southeast Oregon. This wind pattern repeats for most of Tuesday. Cooler showery weather and embedded thunderstorms return Tuesday night through Thursday. Another upper low arrives this weekend to reinforce the cooler temperatures but will not bring significant rain for many areas.
