**WEATHER HIGHLIGHT**

Afternoon temperatures were in the 50s through the Cascades and 60s to 70s across the rest of the Geographic Area. Afternoon relative humidities were 30s to 40s in the Columbia and Harney Basins and above 50 elsewhere. Winds were breezy with stronger gusts through the Cascade Gaps and southeast Oregon. Lightning occurred in eastern Oregon and central Washington. Moderate to heavy precipitation occurred in western Oregon and Washington. Scattered light to moderate precipitation was received in eastern Oregon and southeast Washington. Initial attack was light. Fire behavior was low to moderate.
